

BE INFORMED: ELECTION DAY IS NOV. 6

At its July 30 meeting, the Village of Oak Park Board of Trustees voted to approve placing this nonbinding referendum on the Nov 6. ballot:

“ Shall the merger and consolidation of Oak Park taxing bodies be considered, including, but not limited to, the Village of Oak Park, Oak Park Township, the Oak Park Public Library and the Park District of Oak Park, to determine if there would be efficiencies, the elimination of redundancies and/or property tax reduction for the residents of Oak Park? ”

❓ What is a nonbinding referendum? This is a question included on a ballot during a village-wide election. A nonbinding referendum is often used to provide evidence of community support before projects are planned or actions are taken.

❓ What data are there that would result in a property tax reduction for Oak Park taxpayers?
At this time, there is no known data.

❓ In what ways do these agencies demonstrate fiscal responsibility now?

- **Oak Park Public Library:** By 2021, taxes collected by the library are expected to be less than those collected in 2015. Here’s why: In 2000, Oak Park voters approved a \$30 million bond issue to build the current Main Library building and renovate Maze Branch. By 2020, that resulting bond debt will be paid off.
- **Oak Park Township** served the needs of 20,500 individuals in the 2017-18 fiscal year. The township continues to operate within the property tax cap limitations, and have never issued bonds or other debt. The township has consistently kept expenses low through cooperative purchasing, shared services and outsourcing functions.
- **Park District of Oak Park** is becoming less dependent on property tax dollars. In 2012, only 29% of the park district’s revenue came from fees and charges. In 2017, 49% came from fees and charges, sponsorship and donations, and intergovernmental agreements.

❓ What percent of a tax bill is the library, township and park district? Together, the library, township, and park district account for roughly 11.5 percent. This would mean \$1,380 for a \$12,000 tax bill, the median in Oak Park for the 2016 taxes paid in 2017, according to the township.

Key registration dates

- **Tuesday, Oct. 9:** Last day to register to vote by paper application
- **Wednesday, Oct. 10:** First day of grace period registration (an extension of the regular registration deadline, specific to registrar location)
- **Sunday, Oct. 21:** Last day to register to vote by online application

Registration eligibility

You must be:

- A U.S. citizen,
- At least 18 years old by the general election, and
- A resident of your precinct at least 30 days prior to Election Day.

To register in person, bring two pieces of identification. Neither needs to be a photo ID, but one must include your current address.

Ballot background

❓ How is local government structured?

Oak Park government consists of six taxing bodies, each with its own independently elected board of trustees: the Village of Oak Park, the Park District of Oak Park, the Oak Park Public Library, Oak Park Elementary School District 97, Oak Park and River Forest High School District 200, and the Township of Oak Park.

❓ All of these taxing bodies are affected by tax caps.

In 1991, Illinois passed a tax cap law that places a ceiling on the amount of taxes the park district, library, and township may levy without a referendum. In addition, under current Illinois state law, the Oak Park Public Library is not a separate library district but is a municipal library. This means that the Village of Oak Park must approve all of the library's tax levies and that the library cannot go to referendum independently of the village.
